Ozon Announces Guidance for the Full-Year 2023

April 28, 2023 – Ozon Holdings PLC (NASDAQ and MOEX: “OZON”, thereafter referred to as “we”, “us”, “our”, “Ozon” or the “Company”), an operator of the leading Russian e-commerce platform, updates on the outlook for the full-year 2023.

The below forward-looking statements reflect Ozon’s expectations as of April 28, 2023, and could be subject to change, and involve inherent risks which we are not able to control, for example any global supply chain issues, as well as political and economic conditions in Russia.
